Required Supporting Documentation:

Every foreign traveler is required to provide the above documentation in order for our immigration provider to successfully complete an assessment and supply each foreign traveler with the appropriate travel documents to enter Canada. This adheres with IRCC (Immigration, Refugees and Citizenship Canada)

Travelers misrepresenting themselves at the border or not possessing the correct documentation to enter the country may be subject to personal consequences ranging from being denied entry into the country, confiscation of their passport and potential to be flagged, which will affect all future travel to Canada, whether for personal or business reasons.
