Suncor Energy responds to cyber security incident

Calgary, Alberta (June 25, 2023) – Suncor (TSX: SU) (NYSE: SU) has experienced a cyber security incident. The company is taking measures and working with third-party experts to investigate and resolve the situation, and has notified appropriate authorities.

At this time, we are not aware of any evidence that customer, supplier or employee data has been compromised or misused as a result of this situation.

While we work to resolve the incident, some transactions with customers and suppliers may be impacted.
