



Suncor's integrated procurement ecosystem

Suncor's procurement processes are managed using SAP's S4, Ariba and Fieldglass systems.

These cloud-based systems enable Suncor's Supply Chain team to collaborate directly with suppliers online to complete qualification, contracting, sourcing, contractor management, purchase orders, invoicing, and payment activities. With easy access to their Suncor account information, suppliers can keep company information and documentation current with Suncor.

Accounts and designated account administrators required by suppliers to do business with Suncor

<p>1. Only one Ariba ID Number (ANID) can be used to transact with Suncor.</p> <ul style="list-style-type: none"> • Suppliers must designate an SAP Ariba administrator. 	<p>2. Goods suppliers on Ariba Business Network use the same Ariba ID Number (ANID) to link Ariba Business Network to their Suncor SAP Ariba account.</p>	<p>3. In addition to SAP Ariba, all service providers require an SAP Fieldglass account and a designated SAP Fieldglass administrator.</p> <ul style="list-style-type: none"> • SAP Ariba to maintain company and banking information; and • SAP Fieldglass to complete service procurement processes.
