

# NOTICE OF A PROPOSED CHANGE TO AN APPROVED RENEWABLE ENERGY PROJECT

**Project Name: Suncor Energy Adelaide Wind Power Project (the "Project")**

**Project Location: Municipality of Adelaide Metcalfe, County of Middlesex**

Suncor Energy Products Inc. (Suncor) was issued a Renewable Energy Approval on December 11, 2013 in respect of the Suncor Energy Adelaide Wind Power Project. Information with respect to the decision on this project can be viewed on the Environmental Registry by searching EBR # 011-8848.

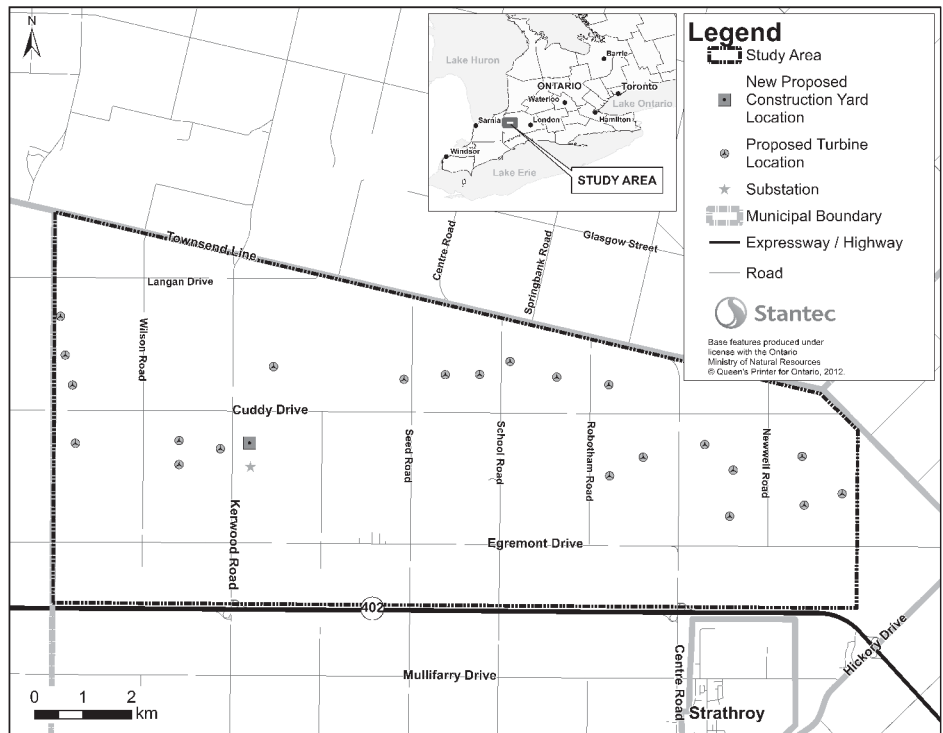
Suncor is proposing to make a change to the project and the project itself is subject to the provisions of the *Environmental Protection Act of Ontario* (Act) Part V.0.1 and Ontario Regulation 359/09 (Regulation). This notice must be distributed in accordance with section 32.2 of the Regulation. This notice is being distributed to make the public aware of a **proposed change to the project**.

## Project Description and Proposed Change:

Pursuant to the Act and Regulation, the project in respect of which the Renewable Energy approval was issued, is a Class 4 wind facility with a total maximum nameplate capacity of 40 MW and consists of up to 18 wind turbines.

An application has been made to the Ministry of the Environment to change the project and alter the terms and conditions of the existing Renewable Energy Approval. The proposed change consists of a minor change to the proposed location of the temporary staging area. The need has been identified for a temporary staging area to be created in an alternate location as approved in the Renewable Energy Approval; however it will still be located on the same property as originally proposed. To supplement a new temporary staging area, Suncor also proposes to change the text within Table 2.1 of the Construction Plan Report as it relates to the Turbine Laydown Areas. Suncor proposes to revise the description of the Turbine Laydown Areas to also include the activities associated with a temporary staging area as described in the Construction Plan Report.

No other changes are proposed to the design of the project or the nameplate capacity of 40 MW. The project location, taking the proposed change into account, is described in the map.



## Documents for Public Inspection:

Suncor has been required to update the supporting documents that are required to form part of the application or which must otherwise be submitted to the Ministry of the Environment available to the public.
